SMEs ELIGIBILITY CRITERIA

- Applicants are citizen of Pakistan doing legitimate business in Khyber Pakhtunkhwa.
- Applicants are affected directly or indirectly by militancy/natural disasters and/or COVID-19 pandemic between June 2008 and June 2020.
- Each member of the group employs minimum of 3 (including owner) and maximum of 200 individuals (except that businesses owned by women and transgender must employ at least 2 workers (including owner) and maximum of 200 individuals.
- SMEs' businesses began operations on or before May 1, 2019.
- SMEs' have proof of business operations for at least one year.
- SMEs' are not a bank defaulter (except if crisis was the reason for default).
- SMEs' grant application has not been already approved/rejected/terminated under ERKP (previously ERKF).
- SMEs' businesses are not on the official negative list (arms and ammunition, explosives, radioactive substances, security printing, alcoholic beverages, etc.)

- 1. Three photocopies of valid National Identity Card duly attested by gazetted Government Officer.
- 2. Written application/request for grant to Project Manager ERKP on business letter head of the Group Leader signed by the applicants including the group head
- 3. Nomination of Group Leader by the applicant SMEs signed by all members on a stamp paper of Rs. 100/-
- 4. Certificate from EPA for the proposed project (if applicable)
- 5. Three quotations from relevant suppliers (3 different suppliers) for the items to be procured under the ERKP grant support.
- 6. NOC from the owners of the company/organization where the machine/equipment will be installed (if applicable) on a stamp paper of Rs. 100/-
- 7. Rent agreement in case the building/premise is rented.
- 8. MOU between the partner applicant mentioning the project's location, partner roles and responsibilities, working mechanism and the signatories.

Documents required for each member/partner separately:

- 1. Proof of business ownership and existence prior to May 1, 2019, at-least one of the following documents;
 - a) Registration with relevant government department (Sales Tax, Income Tax, Industries Department, EOBI, TMA, Labor department and etc (whichever is applicable)
 - National Tax Number (NTN) / Sales Tax Registration Number (STRN)
 - In case any of the members is partner in a partnership firm, Form-H and a partnership deed duly registered with registrar of firms.
 - In case of company, Certificate of Incorporation with Security & Exchange Commission of Pakistan (SECP), Form-A & Audited statements for last three years.
 - b) Registration with relevant Chamber/Registered business association
 - c) Bank Account in the name of business; account title, name of bank, account number, and branch address is mandatory.
 - d) Industrial/commercial utility connection in the name of applicant/business
- 2. Copies of last three months utility (electricity/gas/telephone) bills as proof of business operation (in addition to utility bills attach rent agreements if the business is in rented premises)
- 3. List of existing machinery/equipment and all assets on business letter head
- 4. List of existing full time employees with copies of valid CNIC
- 5. Business Plan, the applicants must also submit a complete business plan showing project's sustainability, costing and implementation plan with clearly defined milestones (maximum 5 pages).
- 6. Any other document that the applicant may submit in support of this application.
