**FINAL RESULT OF SCCI ELECTION 2024-26 FOR EXECUTIVE MEMBER OF CORPORATE CLASS.**

The polling of SCCI Election 2024-26 for Executive committee has been held under Rule 18(15), 21[5 (b;c)] of Trade Organizations Rules (TOR) 2013. The counting of votes, under rule 17(e) and 19(11) of TOR 2013 took place immediately after the polling hours under supervision of polling officer in presence of candidates and their polling agents.

2. In light of Rule19 (9) of TOR 2013 the Election Commission, the election representatives and polling agents agreed and decided amicably about the challenged votes after verification of necessary information before the official provisional results.

3. The Provisional result was declared in light of Rule19 (12) of TOR 2013 by the Election Commission immediately after completion of the counting of votes.

4. After completing the counting and compilation of results, all record pertaining to the elections was signed and sealed by the Election Commission, secretary general and polling agents and was handed over to the secretary general. in light of Rule19 (14) of TOR 2013.


